CANCELLATION / REFUND POLICY

Should a student be terminated or cancel for any reason, all refunds will be made according to the following schedule:

1. Cancellations must be made in person or by certified mail.
2. All monies will be refunded if the applicant is not accepted by the school or if the student cancels within three (3) business days after signing the enrollment agreement and making initial payment.
3. Cancellation after the third (3rd) business day, but before the first class, will result in a refund of all monies paid, with the exception of the registration fee.
4. Cancellation after attendance has begun, but prior to 40% attendance in the program, will result in a pro-rata refund computed on the number of hours completed to the total amount of program hours.
5. Cancellation after attending 40% of the program will result in no refund.
6. The termination date for refund computation purposes is the last date of actual attendance by the student unless earlier written notice is received.
7. Refunds will be made within 30 days of termination or receipt of cancellation notice.

TERMINATION

Any student can be terminated at the discretion of the director for failure to comply with the rules and regulations of the school or delinquency of program payments. The termination date is the last date of actual attendance by the student unless earlier written notice is received.

METHODS OF PAYMENT

Twenty Dollars (\$20.00) is due at the time of signing the Enrollment agreement, and an Eight Hundred Dollar (\$800.00) deposit is required to guarantee a seat for the future start date of the program. The balance of Two Thousand, One Hundred Seventeen Dollars And Five Cents (\$2,117.05) is due no later than 30 days before class start date..

Unity Gain Recording Institute offers this twelve month, forty-eight week program to all interested persons who qualify. Graduates who successfully fulfill academic and monetary obligations will receive a certificate of completion. The school will make reasonable efforts to place the graduate according to his/her talents in the audio field, but by no means will guarantee employment. Actual class days (ie. Monday, Tuesday, etc) vary from course to course and will be determined by the school director with individual student scheduals in consideration.
